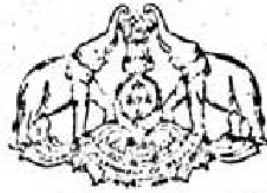

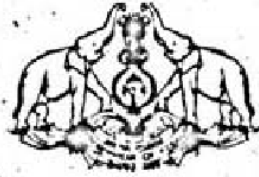

As per sub-rule (5) of rule 3 of the Kerala Abkari Shops Disposal Rules, 2002, Government are empowered to grant beer/wine parlour license in Form 11 under the Foreign Liquor Rules, 1953, to the Kerala Tourism Development Corporation Limited and to other



eligible categories in such of the tourist centers notified by the Government. In the interest of promotion of tourism in the State, Government have decided to include suitable places which are notified as tourist destinations by the Department of Tourism, State of Kerala as tourist centres for the purpose of said sub-rule for which the notification issued under G. O. (P) No. 184/2003/TD dated 20th November, 2003 and published as S. R. O. 1071/2003 in the Kerala Gazette Extraordinary No. 2135 dated 20th November, 2003 has to be amended suitably.

The notification is intended to achieve the above object.
